Report on 2017 Pierre Elliot Trudeau Foundation Society Alumni Survey

Pierre Elliot Trudeau Foundation Society, Executive Committee

Introduction

In the weeks leading up to the 2017 Summer Retreat, the Trudeau Society's Executive Committee launched a brief survey to consult wider the Pierre Elliot Trudeau Foundation community (including both former and current Scholars, Fellows and Mentors) on what should be the purposes and priorities of the Society, as well as to gauge general awareness of and interest in the Society.

The survey comprised 10 questions in both French and English versions. It was circulated via email on March 29th and April 14th to 445 community members. This report provides a summary of the survey's main findings and proposed follow-up actions.

Respondents

The response rate for the survey was 12% (N=445), of which 69% were Scholars, 19% Fellows and 13% Mentors. Of the 54 total respondents, 39 were alumni. Four out of five respondents self-identified as academics or researchers, while the rest included representatives from government, community leadership, business, and arts and media.

Three quarters of the sample currently reside in either British Columbia (26%), Ontario (26%) or Quebec (28%). Other provinces mentioned were Alberta, Manitoba, and Nova Scotia, as well as six respondents from outside Canada (11%).

Roles and Activities

When asked to rank possible roles for the Society, the most popular response was to *assist alumni to bring their research to wider public audiences* (scoring 4.19 out of 6.0), such as helping to translate research work into more publicly accessible formats and organizing collective book launches. Given that 80% of respondents were academics, this would seem to be an important area of activity that could help Trudeau alumni and wider community.

A close second was the Society's role in facilitating communication and social networking among alumni, such as by coordinating a listsery, online directory and social gatherings (scoring 4.13). Among French respondents, this was the most important role for the Society.

The least important roles for the Society, according to respondents, were supporting Foundation activities and representing alumni in Foundation governance structures. However, it should be noted that this does not mean these activities were not important to respondents; it simply means that they were lower priority. Roles of assisting alumni to

access policy-makers and building professional networks were considered as of medium priority.

In response to open-ended questions on roles and activities, respondents proposed a wide range of types and possibilities. Among them were ideas around facilitating formal and informal dialogues around current issues, such as round tables, webinars, regional and thematic workshops; supporting research collaboration and professional networking, such as joint book launches and publication projects, grant writing and professional development workshops, liaison with media and government, arts-based events, and study tours; organizing informal social events, such as wine and cheese, 5-à-7 cocktails, alumni dinners, connecting old with new Trudeau communities; and direct attention to specific issues, such as direct assistance to the poor and indigenous land rights. It should be noted that the Foundation is already active in organizing similar activities, and so the Society would have to assess how its work can complement these existing activities.

Furthermore, respondents showed a high willingness to help organize Society activities. Some 72% of respondents indicated that they would be either "very likely" (30%) or "likely" (42%) to help organize the activities they proposed.

Communication and Visibility

Perhaps the most significant finding to emerge from the survey was the low response rate, a mere 12% of the Trudeau community.¹ While the survey was unable to determine the precise reasons for this (whether too busy or uninterested, for example), respondents also suggested that the Society's communication and transparency could be improved significantly.

For example, some respondents suggested having very little knowledge or awareness of the Society:

I never hear from the society and I am not aware of any events.

I, for one, know almost nothing about this entity.

¹ By the Foundations ####, it was found that only ### opened the email with the survey. Hence, among those whom we know to have at least seen the announcement for the survey, the response rate was slightly improved to a rate of 30%. Of those who actually clicked on the survey link, %% completed it. Again, the survey was unable to determine the reasons for why the 40% did not open the email or even whether that email reached them.

Among the possible media suggested for improving communication within the Society, respondents show a relatively even preference among them, namely ad hoc emails (30%), newsletter (20%), webpage (19%), annual meeting (17%) and a listserve (12%). More importantly perhaps, nobody selected "none" as an option, suggesting that the medium of communication was not so important as the plain need to improve communication.

Next Steps

To address the concerns raised in the survey, the Executive Committee has initiated some preliminary actions.

For one, the Executive Committee is currently looking into options for establishing a more regular contact with alumni through a listserve. While the listserve may have been the least popular choice among communication media (12%), it is a first step that can be set up relatively quickly and easily. Other options, such as a newsletter or a more interactive online database, will be explored later.

Second, the Executive Committee is looking to be more pro-active in updating and maintaining its webpage on the Foundation website. Actions have also been taken to create a separate URL for the website (which can be easily shared and circulated), as it currently takes the three well-informed clicks to get to the webpage from the Foundation website's home page.

Third, what is clearly a key constraint to Society activities in the past and now is busy schedules and limited resources. To address this need, the Executive Committee is currently trying to re-establish Regional Committees, which would help with recruiting members and organizing Society activities.

Finally, it is important to note that because of the low response rate, the findings of this survey do not necessarily reflects the attitudes and opinions of the entire alumni or Trudeau community. However, as they are all we've got, they are what we have to work with for now!
